This can be done visually and/or with confirmation from a parent/caregiver/guardian. The classroom teacher will do visual screening in case of any symptoms. In case the screening indicates the student may be symptomatic, the student will be directed to the designated isolation area. Staff will follow the established protocol from the communicable disease guidance. Students will follow handwashing or hand sanitizing guidance inside each classroom. <h4>Screening Staff</h4> <ul style="list-style-type: none"> Staff members are required to participate in screening, hand hygiene, and temperature checks before entering the building. Staff members are required to report when they may have been exposed to COVID-19. Staff members are required to report when they have symptoms related to COVID-19. Staff members are not responsible for screening other staff members for symptoms. <h4>Ongoing</h4> <ul style="list-style-type: none"> Weekly note: reminders to parents to report actual symptoms when calling students in sick as part of communicable disease surveillance. Any student or staff known to have been exposed (e.g. by a household member) to COVID-19 shall not be allowed on campus until the passage of 14 calendar days after exposure and until symptoms (e.g. fever, cough, shortness of breath, sore throat, headache) are improving. Do not exclude staff or students who have a cough that is not a new onset or worsening cough (e.g. asthma, allergies, etc.) from school. Parents/guardians can provide information
